EXPERIMENTAL TARIFF

RESIDENTIAL ELECTRIC VEHICLE CHARGING RIDER

Availability

This Residential Electric Vehicle Charging Rider (“Rider”) is available, on a voluntary basis, for up to 1,000 Residential Customers in Trico Electric Cooperative, Inc.’s (“Trico” or the “Cooperative”) Certificated Area where Trico’s facilities are of adequate capacity and the required phase and suitable voltage are in existence and are adjacent to the premises served.

This Rider is not available to the following Customers:

1. Customers with Trico loans or special billing.
2. Customers on Trico’s Residential Prepaid Service (RPS) tariff.
3. Customers on Trico’s Residential Time of Use (RS2TOU) tariff.

This Rider also is not available for resale, breakdown, temporary, standby, auxiliary service, or service to electrical equipment that causes excessive voltage fluctuations.

The standard Rules, Regulations and Line Extension Policies of the Cooperative, as on file and updated from time to time with the Arizona Corporation Commission, shall apply where not inconsistent with this Rider.

Eligibility and Application

Customers are potentially eligible to participate under this Rider only if served under the Cooperative’s Residential Service, Residential Service Rate Schedule RS1 for a Single-Family Dwelling (not including apartments or condominiums) where all service is supplied at one Point of Delivery through a single Service Line and Energy is metered through one Meter.

To participate the Customer must make a request and complete an Electric Vehicle Charging Service Application. Moreover, Customers taking service under this Rider must:

1. Provide proof of ownership of a highway approved Battery Electric Vehicle or Plug-in Hybrid Electric Vehicle; and
2. Have a Cooperative-approved Level 2 charger with timeclock charging capability. To remain eligible, the Level 2 charger must remain programmed to charge during the Electric Vehicle Charging Period, defined below. The Cooperative may periodically verify that the charger and the programming remain in compliance and notify Customer of non-compliance. A second instance of non-compliance, after notice from the Cooperative, may result in termination of Customer’s eligibility to participate in this Rider, at the discretion of the Cooperative.

Customer's eligibility to take service under this Rider shall be determined at the sole discretion of the Cooperative.

Service under this Rider will commence when Trico approves a Customer's Electric Vehicle Charging Service Application, confirms appropriate charging equipment is in place and determines that the Customer is eligible to participate under the Rider.

Type of Service

The type of service available under this Rider will be determined by the Cooperative at its sole discretion and is subject to availability at the point of delivery. Service will normally be:

120/240 volt single phase, or 120/208 volt three phase

Monthly Rate

The standard Residential rate, under Residential Service Rate Schedule RS1 shall be applicable for all periods during the month other than the Electric Vehicle Charging Period.

The Electric Vehicle Charging Period shall be defined as the period from 10:00 pm to 5:00 am daily. During the Electric Vehicle Charging Period the following Energy Charge rate shall apply:

First 400 kWh per month	\$0.0650 per kWh
All Excess kWh	At the Standard Rate

All other provisions and charges in the Residential Service Rate Schedule RS1 shall continue to apply.
