Terms and Conditions for Adding a Joint Member

1. Your signature on this Form grants Trico permission to contact you via phone or email in the event of emergencies, debt collection, information purposes or for any other business reason.
2. Your signature also authorizes Trico to process an energy risk assessment through a credit reporting agency to validate identity. *If a social security number is not provided, additional identification will be required prior to processing this request.
3. All balances currently on the account and any future charges to be billed will be the responsibility of all individuals listed on this Form.

Terms and Conditions for Removing a Joint Member

1. By signing this Form, any individual being removed understands and agrees that all refunds, deposits, patronage capital or capital credits, and interest (collectively "Credits") earned jointly will now be solely owned by the remaining member(s) on the account, and does hereby assign all of the undersigned's right, title and interest in the Credits and the Trico membership to the remaining member(s). Assignor shall have no further right, title or interest in any Credits which may be payable now or in the future.
2. All capital credits herein assigned shall be determined solely on the books and records of Trico. If the assignor is indebted to Trico at the time or times the capital credits herein assigned would have been payable to the assignor but for this assignment, Trico shall have the right to offset such indebtedness against the amount which would otherwise be distributable to the assignee.
3. Any balance accrued, up through the date of this Form, is jointly and separately owed and this does not relinquish any person from the responsibility of making full payment.

Terms and Conditions Regarding Primary Member

1. As a joint member on the above Trico Account ("Joint Membership"), I agree that the person appointed as the Primary Member shall act in that capacity. Any refunds, deposits, patronage capital or capital credits (collectively "Credits") owed to the Joint Membership shall be owed and distributed to the Primary Member or, if in the form of a bill credit (as determined by Trico in its sole discretion), applied to the account listed on this Form. The Primary Member shall be solely responsible for distributing any Credits provided to the Joint Membership to the other members of the Joint Membership.
2. I further agree that if: 1) the Joint Membership terminates; 2) I no longer reside at the address listed above; 3) upon my death; or 4) I no longer meet the requirements for membership (or joint membership) described in Trico's Bylaws (as amended from time to time), any and all of my rights regarding Trico or Credits, the listed Trico account and/or the Joint Membership (including rights to past or future capital credits) will be deemed immediately transferred and assigned to the listed Primary Member, or if I am the Primary Member then transferred and assigned to the remaining joint members.
